The County of San Jacinto will hold a public hearing at 5:15 p.m. on Wednesday, April 14, 2021, at the San Jacinto County Courthouse regarding the submission of an application to the Texas Department of Agriculture for a Texas Community Development Block Grant Program (TxCDBG) grant for one or more of the above Funds.
